



Terms of Service

1 General

- 1.1 All deposits are **non-refundable**. A 50% deposit is required when booking appointments. This holds a time slot for that specific vehicle, of which other vehicles will not be taken. It is also used to order parts & materials ahead of vehicle arrival. Time slots may be rescheduled up to two (2) times. If additional rescheduling is required, a new 50% deposit will be required.
- 1.2 AVANT Design & Auto Spa LLC is not liable for any personal items left in vehicles.
- 1.3 AVANT Design & Auto Spa LLC is not liable for any prior damage to vehicle including, but not limited to, scratches, chips, dents, and fading. All vehicles will go through inspection during customer drop off to be signed off on by the customer.
- 1.4 Vehicle to be picked up no more than 3 business days after completion of work. Customers who do not pick up their vehicle within three (3) business days of completion will be charged \$100.00 per day for vehicle storage until vehicle is picked up.
- 1.5 Customer is aware of all law requirements related to vehicle modification in their state. Customer agrees to hold AVANT Design & Auto Spa LLC and any related product dealers harmless if determined that product is illegal.
- 1.6 AVANT Design & Auto Spa LLC reserves the right to use all photos, videos, and audio taken of work completed for promotional, marketing, and any other purposes on behalf of their benefit unless customer explicitly requests otherwise.

2 Vinyl/PPF Installation

- 2.1 AVANT Design & Auto Spa LLC is not liable for paint peeling, flaking or other damage occurring during installation or removal of film and other aftermarket parts or non-factory, defective, or deteriorating paint jobs.
- 2.2 AVANT Design & Auto Spa LLC will advise against installation over aftermarket paint jobs or aftermarket parts that are deemed to be unsafe for wrapping or may result in damage during installation or removal. These areas will be signed off on by the client prior to installation.
- 2.3 AVANT Design & Auto Spa LLC reserves the right to outsource printing of custom designs and stickers to a third party as required.

- 2.5** All film installations will abide by film manufacturer warranty. For specifics, please refer to respective brands Warranty Information.

Tint

- 3.1** AVANT Design & Auto Spa LLC reserves the right to outsource tint installation to a third party as required.
- 3.2** All tint installations, with the exception of windshields, come with a lifetime warranty. Without customer receipt, warranties will be invalid. Warranties are non-transferable. Warranty claims must be approved by the dealer. No warranty on tinting over existing tint.
- 3.3** Do not roll down windows for 5 days after completion while film settles. There may be water under the film. This will evaporate. AVANT Design & Auto Spa LLC is not responsible for tint that does not adhere to dot matrix or defrosters due to removal.

Wheels & Tires

- 4.1** AVANT Design & Auto Spa LLC is not responsible for wheel or tire malfunctions due to manufacturer defects.
- 4.2** Wheel and tire warranty lengths are specified per manufacturer.
- 4.3** All warranty claims must be approved by the manufacturer.
- 4.4** A 50% non-refundable deposit is required to order wheels that are not in stock to begin build process. The remaining 50% will be due upon delivery of wheels. Exceptions may apply.
- 4.5** All tire sales are final upon leaving the AVANT Design & Auto Spa LLC premises unless a warranty claim is filed with the manufacturer.
